New Business Discussion

Bucky's Carwash Driveway Expansion

- Bucky's submitted request to rezone parcel to the south acquired in 2007 as general commercial
 - They need to rezone as general commercial or they would lose entrance points off dodge and ability to service automobiles
- They were cited by the city for pouring a drive on the parcel without a permit
- Bucky's will sign a development agreement that states:
 - Developer will not use property for any other purpose other than gas service station, convenience shop and automatic car wash
 - Developer will not use driveway for any other purpose than access to and from service station
 - o Developer will not construct any other building or structures on the property
 - o Developer can remodel existing structure in accordance with city code
 - Developer will maintain landscaping, paved surfaces and improvements in accordance with city code
 - Any buyer in the future will also have to abide by the agreement
- The plan for the lot
 - o 6 foot fence around drive
 - Landscaping to block headlights and traffic
 - Improved drainage
 - This will cause no change in traffic

- Motion / 2nd by Romero / Mulhall to write a letter on behalf of Dundee Memorial Park Association in favor of Bucky's plan to rezone with development agreement. 9 approved. One opposed. Not unanimous

DVG Realty Condos

- Mary Wells is helping DVG Realty with a TIF Application
- DVG Realty is Jeri and Mike Schlickbernd
- They are developing townhomes at 626 & 636 N 46th St
- The 6 units will be high end 2000 plus sq feet townhomes that will sell for around 450-500k
- With the TIF money they will repair the sidewalks, do street repairs and dirt work

Valero 52nd and Leavenworth

- Attempting to upgrade liquor license which is a violation of agreement made with neighborhood
 - o Also a violation of the "good neighbor" ordinance through the agreement
- Going to City Council November 20th
- The ordinance provides the remedy and, as a board, we are requesting the city to exercise its authority and duty to proceed with that remedy. Motion $/ 2^{nd}$ by Romero / Mulhall. Unanimous vote to Approve.
